SEPTAGE WASTE DISPOSAL FEES

Waste Type		Rate per gallon	Minimum Charge	Notes
Type 1	Sewerage Waste	\$ 0.0305	\$ 91.50	Sewerage holding tank waste and other un-prohibited low strength wastes with a chemical oxygen demand less than 900 mg/L.
Type 2	Septage Waste	\$ 0.0810	\$ 91.50	Septic tank waste and other un-prohibited medium strength wastes with a chemical oxygen demand greater than 900 mg/L.
Type 3	Chemical Toilet Waste	\$ 0.2315	\$ 115.75	Chemical toilet waste and other high-strength wastes with a chemical oxygen demand greater than 10,000 mg/L.

Septage Waste haulers must apply for and receive a septage hauler permit from the District prior to disposing of any Septage at the wastewater treatment plant. Waste must pass the appropriate screening tests before acceptance by the District for disposal.

The District accepts limited amounts of yard waste for disposal. Yard waste includes horse manure, hay, grass clippings and wood chips. Fees must be paid in full at the time of delivery, CASH ONLY. Proof of residency is needed to avoid non-resident surcharge.
